I would like to draw your attention to the PCAHA Rules and Regulations, Section K(6), which states as follows:

Complaints regarding on-ice officials must be made in writing on Association letterhead and signed by the President (or, in the absence of the President, a Vice-President) or Referee-in-Chief of the Association. It will then be forwarded to the BC Hockey Referees Committee Member (RCM) complete with a copy of the gamesheet. A copy will also be sent to the BC Hockey District Director only. The RCM will investigate the complaint and take any action necessary with regards to disciplining officials. Alternatively, if a complaint is found to have embellished or misrepresented events, the RCM will forward the matter on to the appropriate PCAHA Managing Director who will take appropriate disciplinary action against the person(s) responsible.

The purpose of this reporting procedure is to identify officiating problems and allow the people responsible for referee development to take corrective action if warranted.

Please note the following:

1. Complaint letters should be factual and to-the-point.
2. The letter should be forwarded to the BC Hockey Referees Committee Member in whose zone the game in question was played. Please refer to the enclosed RCM Association Responsibilities.
3. The District Director's copy should go to the District Director responsible for Match/Gross penalties for the division (Bonnie Cameron for Midget/Juvenile, Lochie Bell for Bantam, and Neil McNabb for PeeWee and below and Female Hockey).
