

Similarly, the Managing Director, Female Hockey, is elected at a meeting of the PCAHA Female Hockey Committee, subject to ratification at the Annual General Meeting.

Completed forms can be submitted to the Committee as above or via the PCAHA Office. To assist the Committee in its deliberations, I would ask that completed forms be submitted by not later than **Friday, May 19, 2010.**
